- 2019: XX new student-athletes recruited from Georgia, Maryland, Michigan, Canada
- Current team standings
  - o Most wins in a single season in KSU history
    - 7 wins / 8 losses
- National Rankings
  - #2 in country in ground balls per game
  - o #3 in country in draws per game
  - o #6 in country in shots per game
  - #13 in country in scoring offense

    - New facilities (residents halls) are what recruits are looking for when selecting a University
    - KSU has majors that lead to a career after college athletics
    - Challenges getting residents housing for the student-athletes
  - How strong is high school lacrosse in Georgia?
    - Not as strong as other high schools in the North

 Only Division 1 Women's Lacrosse opportunities at KSU and Mercer, so her goal is to recruit Georgia's best supplementing the roster with national and international student-athletes

# Approval of the Minutes

## State of the Department

Vaugh Williams presented the State of the Department.

- 52 student-athletes graduating in May
- Several student-athletes will be attending summer school
  - \$350,000 spent on summer school for student-athletes
    - Most spent on summer school in Athletics history
    - Summer school enables the student-athletes to graduate on schedule
- Baseball
  - o 7-5 in conference play
  - o Currently in 4th place
- Men's Golf
  - Won ASUN Conference Championship
  - Won ASUN Tournament
  - o Freshman of the Year
- Women's Golf
  - Finished 3<sup>rd</sup> in ASUN
  - Player of the Year
  - o Women's Golfer of the Year for 2<sup>nd</sup> year in a row
- Women's Lacrosse
  - Coach Maness from Detroit Mercy
  - Most wins in the history of the Lacrosse team
- Softball
  - o 8-6 in conference play
  - 0 32-15
  - $\circ$  Ranked in top 5<sup>th</sup> of the country
    - 32 RPIs
- Men's & Women's Track and Field
  - Won Indoor Championship
    - Men for the 5<sup>th</sup> time
    - Women for the 1<sup>st</sup> time

- Andy Eggerth Coach of the Year
- Men's Tennis
  - o Finished 3rd
    - Best finish in team history
  - Simon Pritchard
    - 1st Team All Sun
    - Dr. Waples Total Person Award
    - 3.97 GPA from Coles College of Business Department of Finance and Accounting
  - o Team GPA 3.61
- Women's Tennis
  - o 6th place
- Women's Basketball
  - o Participated in the conference tournament for the first time in team history
    - Won the first round of the tournament
  - Hosted first conference tournament in team history
- Anonymous donor gave \$25K to both Men's and Women's basketball (\$50K total donation)
- Football
  - o 2,500 attended the Friday night Spring game
  - o 75-80% ticket renewal sales for next season
    - Ahead in season ticket purchases from April 2016
    - Plans for more student engagement on football game day
- Hired an Associate AD for Finance for the Athletics Department
- Annual Dot Martin Golf Tournament on May 8, 2017 at Marietta Country Club
- Strategic Planning Process
  - SWOT analysis completed
  - Survey completed
  - Focus groups are scheduled
  - Action steps and assessment of accomplishments are next in the process
  - o ETA for completing the Strategic Plan: 2 − 2 ½ months
  - Strategic Plan will cover the next 2-3 years
- Fund raising
  - Football facility
  - Tutoring facility for SASS
  - Sports medicine / strength and conditioning facility

## Compliance Report

#### Heath Senour

- Provided a handout of progress of self-reports that have been submitted to the Conference Office and NCAA
  - Least amount of self-reports to date: 17
  - Vaughn commented that KSU is the University with the highest number of self-reports
    - This is an indicator that the Coaches are doing a great job and a high number of self-reports is a positive thing for KSU Athletics, supporting student-athlete character and integrity
- Provided a handout of Coaching Staff education sessions
  - Legislative Council adopted proposals that are moving to the Board of Directors for vote
  - PAOC was invited to attend the review of these new rules with the Coaching staff scheduled for May 18, 2017
  - New legislation will be effective August 1, 2017

## NCAA Updates

## Vaughn Williams

- Division 1 NCAA Council
  - o 60 members of this Council nationwide
- Serving on a Legislative sub-committee that reviewed 110 proposals
- Early recruiting/early signing day for Football
  - If approved in the next two days, early signing may be a benefit to the student-athletes
- How to get recruiting back in alignment and under control
  - Women's Lacrosse is taking the lead
  - When can high school student-athletes can be contacted/signed/give a verbal commitment
  - Some high school student-athletes are being recruited as early at 9<sup>th</sup> grade
  - Legislation pending nationally to limit recruiting to Junior year of high school
  - o Legislation effective April 15, 2017
    - Women's Lacrosse Coaches are no longer allowed to receive communication from prospective student-athletes or their parents prior to September 1st of the prospective student-athlete's Junior year of high school

- Women's Lacrosse Coaches are no longer allowed to take unofficial visits
- This could impact what is already scheduled for KSU Women's Lacrosse, which may require KSU filing a waiver to allow the student-athlete to attend their pre-planned unofficial visit
- Legislation to lengthen Football season (from the A5 Level)
- Time demands of student-athletes
  - o Form that outlines the expectations the University has of student-athletes
- Brittney Reed provided an update of the study-abroad legislation
  - For student-athlete professional development, student-athletes can participate in study-abroad programs
    - Time in a study-abroad program does not count against their 5year eligibility
    - Same for co-ops, internships, and pre-professional employment

### FAR Update

## Dan Niederjohn

- Exception Request for PAOC Policy handout was approved by the PAOC Executive Committee on April 12, 2016
- Women's Basketball requested to compete in a home game the day before finals start in the Fall semester this was approved
- End-of-season surveys and exit interviews pending
  - Will be reported at September 2017 PAOC meeting
- Randy Kennedy sent out notifications to the Coaches with student-athletes' schedules so any conflicts with finals week can be addressed
